I hereby grant your employees permission to operate my vehicle for the purpose of testing and / or inspecting as necessary.

Upon completion of the vehicle, any deductible, betterment or customer pay items must be paid in full. I understand that the vehicle will not be released to me until payment is received or arrangements have been made for payment. An express mechanic's lien is hereby acknowledged on above vehicle to secure the amount of repairs thereto.
